SMART Recovery sponsors face-to-face meetings around the world, daily online meetings as well as an online message board and a 24/7 chat room

SMART Recovery Online (SROL) - SROL offers online meetings, active message boards and a 24/7 chat room to assist individuals desiring to overcome addictions. The meetings and related online services teach self-empowerment, self-reliance and tools and techniques for self-directed change. During the year ended December 31, 2015, 114 online meetings were held each month. Message board registrations averaged 1,769 individuals each month. Participation in the 24/7 chat room continues to grow.

Bookstore - SMART publications are sold via our online bookstore and over the phone

Distance Training - SMART Recovery face-to-face meeting facilitators and online facilitators and volunteers are required to participate in our monthly Distance Training program. The training is provided via a Moodle delivery platform and almost all study is completed online, with one meet-and-greet meeting, a role play and a final meeting with the President as each session concludes. During the year ended December 31, 2015, 2,069 registered for training, 1,095 graduated and 38% started meetings before the end of 2015
